- Import Freight & Insurance will be paid extra on actual basis after submission of final bill.
- Value of spare parts will be paid in INR as per conversion value of USD/any other currency on the date of transfer of payment. The payment will be made as per proforma invoice raised by the supplier.
- Standard warranty of items should be covered as per OEM.
- Custom duty, IGST and custom clearance charges will be paid to the vendor before delivery of items as per actual cost mentioned in the Bill of Entry.
- The shipment will be on High sea sale basis.
- The supply order will be issued on ***Aircraft on Ground (AOG)*** basis.
- Advance amount required by the vendor should not be more than the value of spare parts only.
- Payment of this consignment shall be settled within one month after delivery of ordered items.
- Supplier should intimate about number of consignment expected for delivery of items in the quote.
- Authority reserves the right to cancel any/all bids without assigning any reason and exclude any items mentioned above.
- Documents required for custom clearance of items will be provided by the PAC as per intimation of the supplier.
- Bid can be submitted by registered post/speed post/by hand. Bids received after due date will not be accepted and considered.
- Lead time of all items should be given clearly and will be adhered strictly by the supplier. In case of delay, decision to imposed penalty will be taken by the authority as deemed fit.
